IRC 2018 Project Spotlight

Lake Ida Parcel



With a grant from Community Foundation for Palm Beach and Martin Counties, IRC has conducted restoration work at the Lake Ida Parcel in Delray Beach. This year, IRC has conducted bimonthly flora and fauna surveys, hosted 6 volunteer day events, and collected survey data on the volunteers. In working with the volunteers and Delray Beach Parks and Recreation, IRC has opened up the southern and eastern portions of the site by removing invasive plants, picking up trash, and planting native species in the areas opened.

Pine Rockland Initiative





With funding from the U.S. Fish and Wildlife Service and in collaboration with private landowners and Miami-Dade County EEL program, IRC has conducted and continued to work on pine rockland habitats throughout Miami-Dade and Monroe Counties. In the past year, IRC's field crew has worked on over 130 acres of pine rockland treating non-native, invasive plants and native hardwood reduction. IRC has worked at over ten sites including county-owned and privately owned pine rocklands and has held several volunteer days. For this upcoming year, IRC plans to work on at least 60 acres of pine rockland throughout Miami-Dade and Monroe Counties.

Croton Project





IRC has continued to work at the National Key Deer Refuge in Monroe County by planting and monitoring Pineland croton (*Croton linearis*) through a contract with the U.S. Fish and Wildlife Service. This year, IRC has replaced the Pineland croton plants that were lost and damaged during Hurricane Irma, prepped new sites for planting, planted more Pineland croton with the help of volunteers, and has collected over 3,000 seeds. This project is to aid in the federally endangered Bartram's scrub-hairstreak (*Strymon acis bartrami*) butterflies, as Pineland croton is the only host plant for the butterfly. In the oncoming months, IRC plans to plant more Pineland croton and continue to monitor the plants for survival, herbivory, and plant recruitment.
